Hair Installation & Styling:

Please note that the above pricing includes hairstyling only, all hair installations, if required, ((including but not limited to wig installations, sew-in and clip-in extensions) should be done prior to the date of your wedding/event by your regular hairstylist.

Agreement/Jurisdiction:

The person(s) whose signature(s) appear on this contract, known as "Client", agree that BRIDES BY INSIGNIA Name known as "MAKEUP ARTIST", shall provide services to apply the best of her abilities, in the manner described in this document. This is a binding contract which incorporates the entire understanding of the parties, and any modifications must be in writing, signed by both parties, and physically attached to the original agreement. Client assumes responsibility for all collection costs and legal fees incurred should enforcement of this contract be broken.

Liability:

Any allergies should be reported prior to application. The Client agrees to release the Artist from liability for any complications due to allergic reactions.

Method of Cancellation/Rescheduling:

In the event of a cancelled or rescheduled event, BRIDES BY INSIGNIA requires a notification in writing 30 days prior to the original event date. If cancellation happens after the 30 day deadline the Client is responsible to pay the full amount. This is the only method of cancellation I will accept. The down payment is non-refundable in any case of cancellation.

Client Responsibilities:

It is the Clients responsibility to provide a safe and adequate working environment for the Artist. The location must include:

- Lots of natural or lamp lighting
- Enough space
- Outlets
- Table for makeup, brushes and hair styling tools
- Enough chairs
- Insurance
- Maintaining clear communication

Payments:

A retainer fee of half of the collection amount is due at the time of booking; this payment is non-refundable and must be paid in order to secure your event day. Last half needs to be paid, at least but not less than, a week before the event day, unless otherwise agreed upon. Payments can be made via Zella or CashApp (Payment Details are available on the invoice sent to the client).

Travel:

A mileage fee will be charged as follows: 0-20 miles (\$2.50/mile), 21-140 miles/km (\$3.00/mile)

Photography:

Photos or videos may be taken for promotional use and advertising purposes online and printed material. Full credit will be given to any professional photos and videos taken by photographers and videograhers
